



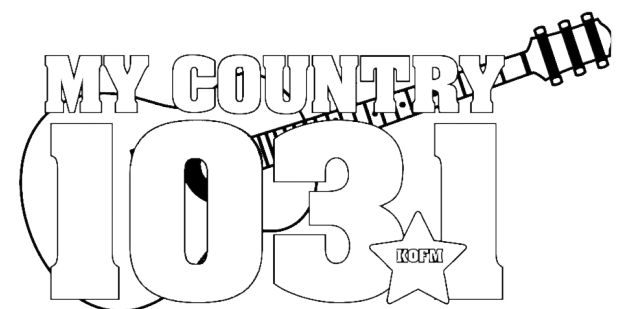

Rules

Winner must be accompanied by an adult when picking up prize.

Winner must claim their prize within FIVE WORKING DAYS after announcement of said winner.

DROP LOCATION ENTRIES.

In the event a contest accepts entry forms by deposit at a Drop Off Location, Williams Broadcasting stations and its sponsors are not responsible for lost, misplaced, illegible, mutilated, or incomplete entry forms, and such entries will be deemed invalid.

PRIZES:

Prizes are specified within individual contest text. Prizes are limited to Prize Sheets only and may not be exchanged or substituted at any time. Prizes are non-transferable and non-exchangeable. If tickets to a performance are awarded as a prize, Williams Broadcasting is not responsible for any cancellation or rescheduling of the performance for any reason and has no obligation to reimburse, refund or otherwise substitute the tickets for another prize should the performance not be rescheduled or vouchers not issued. HOW TO CLAIM PRIZE:
